 *If you donate as a French tax payer*

Tax deduction system

If you donate as a French taxpayer you are entitled to tax deductions:

- ▶ **Income tax:** individuals are entitled to an income tax deduction equivalent to 66% of the amount of their donations, with an upper limit of 20% of their taxable income. For example, a donation of €1,000 will only cost you €340 after tax deduction.
- ▶ **French wealth tax:** individuals liable to French wealth tax may deduct 75% of the amount of their donation, with an upper limit of €50,000. For example, a donation of €5,000 will only cost you €1,250 after tax deduction.
- ▶ **Corporate tax:** all sponsorship donations entitle you to a corporate tax deduction of 60% of their amount with an upper limit of 0.5% of turnover. For example, a donation of €10,000 will only cost you €4,000 after tax deduction.

How to make a donation

▶ By check

▶ By bank transfer

Tax deduction system

- If you are resident in one of the European countries listed below, **you can benefit from the country's tax law, thanks to the Transnational Giving Europe (TGE)**. The TGE is a partnership of European foundations and associations which facilitates the process of making a donation to a general interest organization located in a partner country, **by ensuring it benefits from tax deductions within the country of residence**.
